

**Zodiac Pool Systems LLC**  
**Jandy® Pool Master Cleanup Contest**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES  
NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **ELIGIBILITY:** The Jandy Pool Master Cleanup Contest (the “Contest”) is open to any individual who is a professional working within the swimming pool industry (residential and/or commercial retailers, service technicians, builders and/or remodelers) who is a legal resident of, and physically located within, the fifty (50) United States or the District of Columbia and who is eighteen (18) years or older as of **May 9, 2019**. Employees of Zodiac Pool Systems LLC, any of its parents, subsidiaries, affiliates, advertising and promotion agencies and their family/household members (“household members” includes, parent, spouse, children, and/or siblings), or of any company affiliated with the Contest and collectively with the foregoing person or entities, are not eligible to enter. Each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor (as defined in Section 3 below) which shall be final in all respects. This Contest shall be void outside the fifty (50) United States and the District of Columbia and anywhere else it is prohibited, taxed, or restricted by law. All applicable federal, state and/or local rules and regulations apply.
2. **START/END DATES:** The Contest begins on **May 9, 2019** immediately after the first Contest related post is posted and ends at 11:59 p.m. PST. on **May 24, 2019**.
3. **SPONSOR:** The Contest are sponsored by Zodiac Pool Systems LLC (the “Sponsor”).
4. **HOW TO ENTER:** You may enter the Contest by commenting about a pool recovery (water chemistry improvement, debris cleanup, challenging pool equipment issue resolutions, etc.) with photos, videos, time-lapse, or other rich media types of content on any Contest post published on the **Zodiac’s Facebook page between May 9-May 24, 2019**. All entries become exclusive property of Sponsor and will not be acknowledged or returned. Any use of robotic, automatic, or programmed entry methods, or any entry method which is similar, will void all entries made by the household. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**RULES:**

- To enter, participant must comment on a Contest related post(s) on the Zodiac Facebook page and submit a unique video, photo, time-lapse or other rich media content that they own along with the hashtag #JandyPoolMaster. Participant may submit an unlimited number of unique submissions to be judged in the Contest.
  - The Contest is only open to current and active pool professionals.
  - Entries will be accepted until the Contest ends on 11:59 p.m. PST May 24, 2019.
  - Once the Contest has ended, one entry will be selected by a panel of internal three (3) judges based on the following criteria: 40% creativity/originality, 40% relevance to the contest theme e.g. pool recovery, 20% what best represents Jandy Pool Master Cleanup. In the event of a tie, the three (3) judges shall vote on the tied entries to determine a winner.
  - Participants will be notified and asked for their mailing information.
  - We reserve the right to select an alternative participant if one doesn’t respond via private message within twelve (12) hours of the time the initial private message notification was delivered to the participant.
  - Prizes will be shipped within thirty (30) days after the Contest has ended.
5. **RESPONSIBILITY:** The Sponsor is not responsible for lost, late, incomplete, damaged, destroyed, delayed, stolen, misdirected, illegible or any other inaccurate capture of entries. Entry materials that have been tampered with or altered are void. Entries cannot defame, misrepresent or contain disparaging remarks about Sponsor or any of its products, or other people, products or companies or communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor associates. Sponsor reserves the right to monitor or screen entries and delete, if required in its sole discretion. In case of dispute as to the identity of a winner, such entry will be declared made by (i) the person whose name is on the Facebook account or (ii) the person whose email address was originally assigned by the internet service provider.

- The deadline for submitting comments to count as official entries is 11:59 p.m. PST May 24, 2019.
- Shortly after the entry deadline, a panel of internal judges will review all submissions by all participants and the top entries will be selected as winners.
- Each winner will be notified by a response from the Zodiac Facebook account to their winning Contest entry comment where they will be asked to private message the page to provide mailing and contact information.
- Winners will be notified that the Sponsor has received the mailing address via a response message from the Zodiac Facebook account.
